I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by any employee, representative, or agent of Precision Planting LLC.

I recognize that COVID-19 is a worldwide pandemic and that COVID-19 is extremely contagious and is believed to spread mainly from person to person contact. I recognize that Precision Planting has put in place preventative measures to reduce the spread of COVID-19; however, I recognize that Precision Planting **cannot** guarantee that I or my family members (if applicable) will not become infected with COVID-19. I recognize that attending PTI could increase my risk or my family's risk (if applicable) of contracting COVID-19.

I represent for myself and my family (if applicable) that within the last 14 days that I or my family have (i) not returned from a highly impacted area subject to a CDC Level 3 Travel Health Notice, (ii) not been exposed to any person returning from a highly impacted area subject to a CDC Level 3 Travel Health Notice, or (iii) not been exposed to any person who has a suspected or confirmed case of COVID-19.

I wish to participate in activities sponsored by Precision Planting LLC at the PTI. I recognize that there are certain inherent risks associated with the activities at the PTI. I understand that my participation is at my own risk. In exchange for being permitted to participate in activities at the PTI, I assume full responsibility for personal injury to myself and (if applicable) my family members, loss, or damage.

On behalf of myself, my executors, administrators, heirs, next of kin, successors, and assigns, I release and waive Precision Planting LLC and any of Precision Planting LLC's employees, representatives, and agents (individually or collectively hereinafter "**Precision Planting**") from any and all liability, including but not limited to, liability arising from the negligence or fault of Precision Planting for my death, disability, personal injury, property damage, property theft, infection, or actions of any kind that may hereafter occur to me including my traveling to and from the PTI.

I and (if applicable) my family members indemnify, hold harmless, and promise not to sue Precision Planting from any and all liabilities or claims made as a result of participation in activities at the PTI, whether caused by negligence or otherwise.

I agree to indemnify and defend Precision Planting against all claims, causes of action, damages, judgments, costs, expenses, including attorney fees or any litigation costs, which in any way arise from my or my family's use of or presence on the PTI.

I consent and agree on behalf of myself and (if applicable) my family members that Precision Planting or anyone else at PTI may take photographs or recordings of me as a participant during my activities at the PTI and use these photographs or recordings in any and all media for training or promotional purposes.
